### INSPECTIONS

Sprinkler system Backflow Preventers are very important health and safety devices. These devices prevent the stagnant water in your sprinkler system, irrigation systems, ice machines or boiler from getting into your domestic water supply. Code requires annual inspection and service of these critical devices. Fox Valley Fire & Safety will dispatch a technician to complete this important work.

### SERVICE AND REPAIRS

### FIRE PUMP TESTING

In the event of a fire, your sprinkler system relies on a steady supply of water to extinguish the fire. In a multi-story, high-rise or large building or if you have low water pressure you may have a Fire Pump incorporated into your sprinkler system.

In order to maintain proper pressure and water flow, Fire Code requires annual testing of fire pumps. This testing insures that in the event of a fire, the water supply in your building will support the sprinkler system and the fire can be extinguished. Our trained technicians can inspect, service, repair and maintain your fire pumps to assure they will function properly.
